

# PETITION FOR CONSTRUCTION OF SINGLE COUNTY DRAINAGE IMPROVEMENT [R.C. 6131.04]

Name of Project: Wye Road Flood Mitigation and Improvements Phase 2

**TO THE COUNCIL, COUNTY OF SUMMIT, OHIO:**

The undersigned hereby petition your honorable body for the following improvements:

**Nature of the Work:**

Repair the natural drainage course, which has been subject to severe erosion and has caused flooding due to major storms in recent years and install measures to mitigate the erosive and flooding effect of future storms. Repair of the natural drainage course includes clean, remove obstructions from, regrade, restore, reconstruct, and stabilize the drainage course hereinafter set forth, install natural channel improvements including step pools and riffles in order to reduce channel velocities, scour and flooding. The drainage course location is described as running northeasterly through The Sanctuary of Bath subdivision and continuing downstream, roughly following the west side of Wye Road to Yellow Creek. The Sanctuary of Bath Phases 1 and 2 are residential subdivisions located in Bath Township, Summit County, Ohio, recorded in Plat Cabinet A, Slide Numbers 771 thru 778 (Phase 1), and Plat Cabinet B, Slide Numbers 566 thru 573 (Phase 2), of the records of Summit County, Ohio.

**Course and Termini:**

The following is the approximate course and termini of said proposed improvement, to wit:

Beginning at the downstream terminus of the natural drainage course at its confluence with Yellow Creek, said point being on the west side of Wye Road, approximately 200 feet south of Granger Road (Bath Township);

Thence southerly approximately 300 feet, following the course of the existing piped channel;

Thence, continuing southwesterly approximately 800 feet, following the course of the existing natural channel to the existing stormwater detention basin on Sublot 1 of The Sanctuary of Bath Phase 1;

Thence, continuing southwesterly approximately 1300 feet, following the course of the existing natural channel to the confluence of two natural channels on Sublot 38 of The Sanctuary of Bath Phase 1;

Thence, continuing northwesterly approximately 500 feet, following the course of the northwesterly natural channel, to the improvement terminus, being on Sublot 36 of The Sanctuary of Bath Phase 1;

And including associated easements of access;

The Petitioner(s) state that the construction of the improvement is necessary and will be conducive to public welfare.

Except as may be ordered pursuant to section 6131.31 of the Revised Code, all costs of engineering, construction, and future maintenance will be paid by the County through its Surface Water Management District.

A list of the names and addresses, where known, of all owners of land which the petitioner(s) claims will be benefitted by or damaged by construction of the proposed improvements is attached as Exhibit A.
