



SWMD Mini-Grant

The Mini-Grant application period is open! This grant is a collaboration with Summit County Engineers
Surface Water Management District and Summit Soil & Water. If you live in one of the SWMD communities, then you are eligible to apply to receive funds to install a BMP. Best Management Practices(BMPs) are approaches to water management that protect waterways from pollution and help achieve healthy water quality.

Update from the Engineer's office

Hello SWMD Residents!

2025 is off to a fantastic start, and we're thrilled to share some exciting updates on the initiatives we're working on to keep our waterways clean and healthy!

Let's dive in by talking about the SWMD. You might be wondering, what exactly is the SWMD? Great question! SWMD stands for the Surface Water Management District, which is a stormwater management and utility program administered by the County Engineer's Office. The SWMD focuses on improving stormwater facilities and managing runoff to protect both surface and groundwater quality while preventing flooding and property damage.

You're receiving this newsletter because your community is part of the SWMD. Not all communities within the County are in the SWMD – to date, we assist all 9 Townships, along with the City of Reminderville and the Village of Lakemore with stormwater management and planning.

As you can imagine, managing stormwater and preventing flooding is no easy task – it's a challenge faced by many communities across the state. So, what does that mean for us? In short, the Ohio EPA sets the rules and guidelines of our stormwater management program. These guidelines lay out actions, strategies, and best management practices designed to reduce the flow of pollutants into our waterways, helping to protect both water quality and public safety.

For us, this means implementing a range of stormwater management projects and activities. From stream restoration and flood control to hands-on local outreach initiatives like the SWMD Mini-Grant mentioned earlier, we're working hard to improve water quality, reduce flooding risks, and build more resilient communities. And this year, we're teaming up with organizations like the Soil and Water Conservation District to bring you exciting opportunities to get involved and make an impact in keeping our waterways clean and thriving!

Urban District of the Year



Last month, Summit Soil & Water proudly received the Urban District of the Year Award at the Ohio Federation of Soil and Water Conservation Districts Annual Partnership Meeting.

- Our team was recognized for our widespread efforts, including:
- Completing over 1,800 annual site inspections across more than 300 active construction sites
- Offering a mini-grant program
- Authored multiple approved NPS-IS plans
- Certifying over 500 professionals through our Inspection and Maintenance Certification, with even more earning their QHEI and HHEI certification
- Promoting public participation in our water quality efforts through our volunteer water quality monitoring program, training workshops, and extensive sampling initiatives
- The development of the Water Quality Volumes Spreadsheet Tool, which calculates stormwater management requirements which is now utilized by the Ohio EPA.


